1 ESSENTIAL DUTIES AND RESPONSIBILITIES

- Monitor network performance and address any issues or anomalies.
- Assist in routine maintenance tasks, including updates, patches, and configuration changes.
- Provide first-level support for network-related incidents and service requests.
- Collaborate with the Senior Network Engineer to troubleshoot and resolve technical issues.
- Contribute to the maintenance of network documentation, including configurations and procedures.
- Keep records of network changes and updates for future reference.
- Assist in implementing and maintaining security measures to protect network infrastructure.
- Ensure compliance with security policies and industry standards.
- Work collaboratively with cross-functional teams to support overall network objectives.
- Learn from and contribute to the knowledge base of the Senior Network Engineer and other network support staff.
- Actively participate in training and development opportunities to enhance technical skills.
- Stay informed about industry trends and emerging technologies.
- Mentor and provide guidance to junior network support staff.
