- USA Update:

A lot of time was spent on the budget. Calaveras County was mentioned for damages again. Picked up a new board member from P G & E. Regulatory update has some new member for the safety board. The PUC of Nevada has been speaking at every meeting. He does many updates. He used to be on the 811 board. Nevada is doing a great job on education and damage reports. Marketing and education report was next. The damage percentage is down. The education appears to be working and they will continue the outreach. Goals and progress have been met so far. Tickets are up from last year but below the previous year. Nevada is up by 16% of their best year. Over the last 3 year, there has been double digit budgets. Therefore, this year they were able to agree on a 5.6% increase. We are the third largest by organization behind Texas and West Virginia. Regulation law is having Nevada respond back on the excavator tickets also. This sends a notification out that it is all clear to everyone. The CGA skipped the national update. The finance committee was picked. The 811 board will be having one meeting a year in Nevada. This will be the January 29th meeting. There was an outage on Pelican it lasted about 11 hours in October. Dig Safe board is looking into this to see why this happened. They want to know what the backup plan will be and how this will avoided in the future.
